The meeting was called to order by President Groth. Morrow moved, duly 2<sup>nd</sup> by Tabbert, to approve the agenda. Ayes-Morrow, Tabbert, Falk, Bork, Brumm, Hannam, and Groth. Nays-None.

The Board recognized the visitors.

Falk moved, duly 2<sup>nd</sup> by Morrow, to pass amendment number two to the resolution – Pandemic Response and Emergency Suspension of Policy dated March 19, 2020. Ayes-Tabbert, Falk, Bork, Brumm, Hannam, Groth, and Morrow. Nays-None.

Morrow moved, duly 2<sup>nd</sup> by Brumm, to use third quarter grades for the semester grade and award full semester credit to students for the second semester for grades 6-12. Morrow moved, duly 2<sup>nd</sup> by Hannam, to move graduation to July 26, 2020. If the state is not going to be opened back up for gatherings of more than 50 people, we will put together a virtual graduation and parade to be held on July 26, 2020. Tabbert moved, duly 2<sup>nd</sup> by Brumm, to approve the last student day to be May 22, 2020 but meals to be served through May 29, 2020. The Teachers last day will be June 4, 2020. Ayes-Hannam, Groth, Morrow, Tabbert, Falk, Bork, and Brumm. Nays-None.

Bork moved, duly 2<sup>nd</sup> by Tabbert, to approve the resignation of Jennifer Phillips, Elementary Teacher, at the end of the 2019-2020 school year and to approve a contract for a full bus route for Jim Squier for the 2020-2021 school year at his approved hourly pay.
